UNDERSTANDING THE BIG PICTURE of LIES, DECEPTION, and PERSONAL PROFITEERING.

Over the last decade, the public has been purposely uninformed of the injustices taking place within the Probate Courts of Orange County. The licenced but in violation of Constitution, Rules of Law and decency JD judges type Kim Hubbard and most of her probate colleges from Probate's Court Judges, DDS's attorneys as Pam, attorney from California Attorney General Office under color of authority type of Julie Trinh, and court appointed counsels from Public Defender Department, in particular Holly Galloway at present time have been colluded with con artists such as Director of Orange County Larry Landauer, Director of DDS Nancy Bargmann, felon and owner of the Grouphomes Lou Pena in abusing the Public trust in Justice, State and Federal fundings at their power discretion by taking advantage of Jewish Orthodox descendants of Holocaust Survivors family.

The above mentioned fabricated information and sent false reports to authorities to kidnap Nate Tseglin from their caring family under false pretence of serving Public interest.

Since the family was forcefully separated and Nate was departed from the family in shakeles the intense abuse and Nate torturing started immediately by police beating innocent Asperger's syndrome youngster in the car, then sexually assaulting him in Emergency Room, then enforcing Nate without his and family consents to highly addictive and poisonous drugs, unrelated to his condition.

Notice, this was inforced psychotropic illegal human torturing and drug trafficking performed by the government employees on payroll and supported by the Court on our People's tax payers money.

If an occasional individual for a fraction of their violation would be would be harshly punished but Nancy Bargmann with her unsupervised budget of 8 billions and Larry Landauer the Director of Orange County Regional Center with his unsupervised budget of 500 million have been assisted by the Court and army of licenced attorneys are well protected steal and kill for personal profiteering..

The Court is hypocritical by colluding with immoral and making a good living for the expense of stealing Public money, human and drugs trafficking, parasitizing on the People's expense.



Kidnapping, lying, torturing, isolating and poisoning, and murdering the human beings as Nate with the most toxic but unrelated to Nate's condition drugs and acting as a medical doctor without licence in violation of basic human decency is a new norm of Court and attorneys. It is O.K. for them as long as it is financially beneficial.

These judges are incompetent and are presiding on the bench despite the fact that they *knowingly* have little to no expertise in the area of Probate law. Their minimal understanding and unpreparedness force them to heavily bond with others like them, attorneys and felons such as Lou Pena, Larry Landauer and Nancy Baargmann.

These Judges rely on the misinformation provided by the court appointed attorneys, who "claim" to represent the position of the incapacitated family members.

In reality, what has developed is a broken system, where attorneys abuse this opportunity as counsel to either: (1) drain money from conservatorships or (2) order developmentally disabled people removed from their homes and in many cases, by way of police escort.

These developmentally disabled are placed in handcuffs and taken to the nearest group home, where these facilities are receiving hundreds of thousands of dollars in aid from our U.S. government to provide "services" that they believe are "better" than leaving these children in the care of their own loving families.

This is problematic and what's worse is how many of these cases are being swept under the rug. These families the Public attention. **to decent legal defence and rehabilitation to save Nate's life and restore Justice for other innocent people create more awareness and promote CHANGE.**

THE NATE TSEGLIN STORY

Nate Tseglin, an autistic young man, was forcibly removed from his family home in handcuffs by Orange County police officers at the age of 17. Twelve years later and Nate has yet to be reunited with his loving family. He has been living permanently in a state-run "independent living" group home, where he was encountered multiple instances of physical, verbal, and sexual abuse by his care takers.

A phone call made to Child Protective Services by an indecent individual started this whole catastrophe back in 2007. The social workers claimed instances of self-inflicted scratches on Nate's body, a known behavior associated with individuals who have been diagnosed with Autism.

Not long after this complaint was made, an investigation was initiated, and social workers relied on a psychologist's finding that Nate should be removed from the family home after this psychologist had never even met Nate and only relied on Nate's medical records for his

conclusions. Apparently, Ilya and Riva Tseglin's love, care, and special treatment for their son for the first 17 years of his life was all of a sudden "inadequate" and not enough to cover his medical and everyday needs.

The family, medical doctors, and community have been strongly opposed to the use of psychotropic drugs as treatment for their son, arguing that its side effects have substantially affected their son's overall health. An orthodox Jewish family, the Tseglin's have preferred more of a holistic approach, utilizing a kosher diet and seeking holistic therapy for Nate's care. Despite Nate's diagnosis as Autistic, he has been coerced into taking psychotropic drugs that are typically used to treat individuals with *schizophrenia*, *mania*, and *bipolar disorder* patients. The Tseglin's have reported drastic differences in Nate's personality and interactions with them, as well as a development of seizures that have been continuous since his exposure to psychotropic drugs. Nate is unrecognizable physically, mentally, and emotionally since being in the care of the state.

The Tseglin family has spent the last twelve years fighting the court system to receive conservatorship over their now 32-year-old son. Three times they have received a writ of Habeas Corpus, which ordered that Nate be released to his family, but the Director of Orange County Regional Center - Larry Landauer and the Department of Developmental Services, Nancy Bergmann, refuse to follow this order and provide 24/7 care to the Tseglin within their home.

The critical issues with Nate Tseglin's current placement in the state-run "independent living", is the fact that Nate has been deprived of living a self-sustaining life, where he is given the opportunity to develop and strengthen his social and functional skills, as well as improve upon his intellectual capacities by continuing to seek education that may give him the possibility to be a functioning member of society.

The Department of Developmental Services (DDS) claims to give these developmentally disabled individuals the opportunity and support needed to achieve these things but in reality does the opposite while the Court Judges and army of Attorneys keep pretending with lies and tricks the irreparable damages and extended sufferings to Tseglin's and the People of California..

Nate Tseglin's story is just *one* of the many injustices taking place within the Probate Court system. This is happening *every single day*.

The People collecting the last *decade* representing and documenting these injustices. Outraged by these heartbreaking stories, MacCarley has begun representing several families, including the Tseglin family in pro-bono cases to help these families fight back against this broken court system but as the result she was personally insulted and threatened with sanctions by the same attorneys from California Attorney General Office Julie Trinh and so called attorney from Public Defender Department - Holly Galloway in order to stop her performing her honest duties by demoralizing and resigning her from the case.

MacCarley has also spearheaded the filming of a documentary entitled, "Zealous Advocates: Abuse or Advocacy?", which documents the first-hand accounts of the families who have had to

suffer through years of agony, while also exploring the changes that need to be made within this broken Probate court system.

Of course we have no hope in Judges like Kim Hubbard that was appointed to her bench and illegally occupy it for 13 years but we have a hope that some Judges will take a moral stand.
