This AMENDMENT NUMBER ~~ONE~~TWO to Contract Number MA-060-20010875 (hereinafter “AMENDMENT NUMBER ~~ONE~~TWO”) between the County of Orange, a political subdivision of the State of California, operating through its Sheriff’s Department (hereinafter “COUNTY”) and NicheVision Forensics, LLC (hereinafter “CONTRACTOR”) with a place of business at 526 S. Main St., Suite 714G, Akron, OH 44311 is made and entered upon execution of all necessary signatures.

RECITALS:

WHEREAS, COUNTY and CONTRACTOR executed a Contract for STRmix Probabilistic Software on September 14, 2021, as Contract number MA-060-20010875 (hereinafter “ORIGINAL CONTRACT”), for a two (2) year term of January 1, 2020 through and including December 31, 2022 in a not to exceed amount of \$127,812.50, renewable for two (2) additional one-year terms; and

WHEREAS, COUNTY ~~and CONTRACTOR~~ ~~desires to renew~~ed the ORIGINAL CONTRACT ~~on December 6, 2022~~ for a one (1) year term of January 1, 2023 through and including December 31, 2023 as Contract Number MA-060-22010470, as well as ~~modified~~ ATTACHMENT A, Scope of Work, Section 4. Training, Support, Maintenance, and Upgrades, and ATTACHMENT B, Compensation and Pricing Provisions, Section 2. Fees and Charges of the ORIGINAL CONTRACT in a not to exceed amount of \$38,437.50, ~~and the CONTRACTOR has agreed to continue to provide those goods/services at the rates set forth in the ORIGINAL CONTRACT and this~~ hereinafter “AMENDMENT ONE”;

~~WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT for a one (1) year term of January 1, 2024 through and including December 31, 2024 as Contract Number MA-060-22010470, as well as modify ATTACHMENT A, Scope of Work, to add the DBLR software system annual maintenance, and ATTACHMENT B, Compensation and Pricing Provisions, Section 2. Fees and Charges of the ORIGINAL CONTRACT in a not to exceed amount of \$46,160,00 and the CONTRACTOR has agreed to continue to provide those goods/services at the rates set forth in the ORIGINAL CONTRACT and this AMENDMENT ONE;~~

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. ARTICLES

a. Additional Terms and Conditions, Section 2, Term of Contract, of the ORIGINAL CONTRACT is amended to read in its entirety as follows:

2. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 1/1/2020 through and including 12/31/2023<sup>34</sup>, unless otherwise terminated by COUNTY.

- b. Additional Terms and Conditions, Section 3 – Renewal, of the ORIGINAL CONTRACT is amended in its entirety as follows:

3. Renewal:

This Contract may not be renewed. ~~by mutual written agreement of both Parties for a one (1) year term. The County does not have to give reason if it elects not to renew. Renewal periods may be subject to approval by the County of Orange Board of Supervisors.~~

- ~~c. Attachment A, Scope of Work, Section 4. Training, Support, Maintenance, and Upgrades of the ORIGINAL CONTRACT is amended in part its entirety as follows:~~

ATTACHMENT AScope of Work

A. Contractor shall provide the County with STRmix Probabilistic Genotyping DNA Analysis System Software ("STRmix Software") and Database Likelihood Ratio ("DBLR Software") Updates. STRmix Software and DBLR shall include all new point and major version releases at no additional cost to County.

1. The STRmix Software shall have the following capabilities:

- Fully continuous probabilistic approach for DNA profile interpretation
- Deconvolution of mixtures containing up to four (4) contributors
- Ability to condition mixtures on known reference samples
- Use of laboratory specific parameters such as analytical thresholds, allele frequency databases, theta values, probability of drop in, and peak variability to develop analysis methods
- Complete system transparency in all statistical methods by providing the formula used within peer reviewed publications
- Allow modeling of allele-specific or locus-specific stutter
- Ability to compare mixed DNA profiles directly against databases of known individuals to generate matches
- Engineered to allow for the addition of any new Forensic autosomal STR DNA typing kit types, allele frequency databases, and sub populations
- The ability to vary the number of contributors in Hp and Hd when calculating an LR from a varNOC run
- Report results in such a manner that OC Crime Lab (OCCL) Forensic Scientists will be able to testify in court regarding the mechanism to which results are produced by the Software.
- Compatibility with the latest Microsoft Windows Operating Systems

2. The DBLR Software shall have the following capabilities:

- Designed for the fast calculation of likelihood ratios (LRs) using either single-source profiles or STRmix deconvolutions.
- Direct comparison of one or more components of a forensic DNA profile to a database of known individuals (i.e. "Who contributed to the profile?")
- Direct matching of profiles between databases of known individuals (by counting matching and non-matching alleles
- Familial searching (i.e. "Is there a relative of the donor in the database?")
- Determine the DNA profile(s) of the most likely contributor(s) to a profile
- Examine whether two or more DNA profiles could share one or two common donor(s) (mixture to mixture comparison)
- Search the genotypes of a queried contributor against a profile database under the assumption that two or more DNA profiles share a common donor (common donor searching)

- Engineered to allow for the addition of any new Forensic autosomal STR DNA typing kit types, allele frequency databases, and sub populations
- Assign LR's for single-source profiles and mixtures within user-defined pedigrees, including incestuous scenarios
- Manage automated searches for one or more DNA profiles against one or more databases of known individuals.
- Compatible with STRmix version 2.3 and later.
- Statistical methods are explained in peer reviewed publications.
- Compatibility with the latest Microsoft Windows operating system.

3. Training, Support, Maintenance, and Upgrades:

- Contractor shall provide a maintenance and upgrade plan that includes all new point and major version releases at no additional charge.
- All technical support necessary to install and operate the new software versions and updates, including expert resolution of general STRmix and DBLR Scientific Support questions.
- Scientific support includes trouble shooting, case specific queries, general email queries and advice, but excludes validation, platform upgrade or version upgrade support.

4. Requirement:

- Once Contractor's software is installed by County's OCCL personnel, the software must be able to meet County's specifications listed above and shall perform to the specifications advertised by the manufacturer.
