**AMENDMENT NO. 4  
TO CONTRACT MA-080-23010392  
FOR  
ON-CALL ARCHITECTURAL SERVICES**

This Amendment is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California, and Orange County Flood Control District, a body corporate and politic ("County"), and Lionakis, ("A-E"), with County and A-E sometimes individually referred to as "Party" or collectively referred to as "Parties."

**RECITALS**

**WHEREAS**, the County and A-E entered into Contract MA-080-23010392 for On-Call Architectural Services, effective December 20, 2022, through December 19, 2025, with a maximum allowable compensation of \$1,500,000; and,

**WHEREAS**, pursuant to Amendment No. 1, the Parties amended the Classification Rates to add Subconsultant; and,

**WHEREAS**, pursuant to Amendment No. 2, the Parties amended the Contract to increase the maximum allowable compensation by \$100,000; and,

**WHEREAS**, pursuant to Amendment No. 3, the Parties amended the Contract to increase the maximum allowable compensation by \$100,000; and,

**WHEREAS**, pursuant to Amendment No. 3, the Parties amended the Classification Rates Table for Subconsultant, BKF Engineers; and,

**WHEREAS**, the Parties now desire to increase the maximum allowable compensation by One Million, Five Hundred Thousand Dollars (\$1,500,000) for a maximum allowable compensation of Three Million Dollars (\$3,200,000); and,

**NOW, THEREFORE**, the Parties agree as follows:

**ARTICLES**

1. Article 1.4. shall be amended to read in its entirety as follows:

The term of this Contract is for three (3) years commencing upon Board of Supervisor approval or upon execution of all necessary signatures, whichever occurs later, with the option to renew or extend for up to two (2) additional years with Board of Supervisors approval, **WITH A MAXIMUM ALLOWABLE COMPENSATION OF THREE MILLION DOLLARS (\$3,200,000)**, except as permitted in Paragraph 1.5 below.

2. Attachment A: Scope of Work, Section I shall be amended to read in its entirety as follows:

OC Public Works on behalf of the County of Orange (County) requires supplemental professional services to meet workload demands and project scheduling commitments in relation to Architect/Engineer (A-E) Design, Project Administration and Management Services for various projects. A-E is defined as an Architect or Engineer for design and/or engineering of a project. To supplement existing resources, County intends to issue a Qualified Vendor List for On-Call Architectural Services for use by Orange County on an "as-needed" basis. No specified amount of work is guaranteed to A-E. However, the amount of negotiated contracted work that will be required on an "as-needed" basis shall not exceed (\$3,200,000).

3. All other terms and conditions of the Contract shall remain unchanged and with full force and effect.




