

AMENDMENT NUMBER TWO TO CONTRACT NUMBER MA-299-20010242 FOR Hydroseeding Services

THIS Amendment Number Two ("**Amendment**") to Contract Number **MA-299-20010242** for Hydroseeding Services ("**Contract**") is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California, through its OC Waste & Recycling Department ("**County**") and **Ron Dietz, Inc. dba Dietz Hydroseeding Company**, with a place of business located at 15745 Kadota Street, Sylmar, CA 91342 ("**Contractor**"). County and Contractor are collectively referred to as "**Parties**."

RECITALS

WHEREAS, Contractor and County entered into Contract Number MA-299-20010242, for Hydroseeding Services ("**Services**") under a firm-fixed price Contract for three (3) years, effective November 23, 2019 through November 22, 2022, in an amount not to exceed \$1,050,000; and

WHEREAS, County revised Attachment A, Scope of Work and Pricing, and renewed the Contract for one year, effective November 23, 2022 through November 22, 2023, in an amount not to exceed \$575,000, for a cumulative Contract total not to exceed \$1,625,000; and

WHEREAS, County now desires to renew the Contract for one year, effective November 23, 2023 through November 22, 2024, in an amount not to exceed \$365,000;

NOW, THEREFORE, the Parties mutually agree as follows:

- 1. Contract Number MA-299-20010242 shall be renewed for one year, effective November 23, 2023 through November 22, 2024, in an amount not to exceed \$365,000, for a cumulative Contract total not to exceed \$1,990,000.
- 2. All other terms and conditions of the Contract, except as amended herein, shall remain unchanged, in full force and effect.

* If the contracting party is a corporation, two (2) signatures are required: one (1) signature by the Chairman of the Board, the President or any Vice President; and one (1) signature by the Secretary, any Assistant Secretary, the Chief Financial Officer or any Assistant Treasurer. The signature of one person alone is sufficient to bind a corporation, as long as he or she holds corporate offices in each of the two categories described above. For County purposes, proof of such dual office holding will be satisfied by having the individual sign the instrument twice, each time indicating his or her office that qualifies under the above described provision. In the alternative, a single corporate signature is acceptable when accompanied by a corporate resolution demonstrating the legal authority of the signee to bind the corporation.
