AMENDMENT NO. 2 TO CONTRACT MA-080-21010410 FOR ON-CALL ROAD AND BIKEWAY ENGINEERING SERVICES

This Amendment is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California ("County"), and Mark Thomas & Company, Inc., ("A-E"), with County and A-E sometimes individually referred to as "Party" or collectively referred to as "Parties."

RECITALS

- **WHEREAS**, the County and A-E entered into Contract MA-080-21010410 for On-Call Road and Bikeway Engineering Services, effective November 17, 2020 through November 16, 2023, in an amount not-to-exceed \$750,000; and
- **WHEREAS,** Pursuant to Amendment No. 1, the Parties amended the Contract to increase the total Contract amount by \$187,500 for a revised amount not-to-exceed \$937,500; and,
- **WHEREAS**, the Parties now desire to renew the term of the Contract for two additional years, effective November 17, 2023 through November 16, 2025 with a maximum allowable compensation of \$1,200,000; and,
- **WHEREAS**, the Parties now desire to amend Contract article 1.1.2 to update the listed Principal; and,
- WHEREAS, the Parties now desire to amend the Contract Notices to reflect the contact information for the current listed Principle in Charge; and,
- **WHEREAS**, the Parties now desire to amend the Contract Staffing Plan to update the Key Personnel and Subcontractors on file; and,
- WHEREAS, the Parties now desire to amend the Contract Cost/Compensation to reflect the current Classification Rates; and,
- **WHEREAS,** the Parties wish to add the Orange County Flood Control District ("District") as a Party; and

NOW, THEREFORE, the Parties agree as follows:

ARTICLES

1. The Orange County Flood Control District shall be added as a Party to the Contract. A-E shall indemnify the District in the same manner as it does the County. A-E shall name District as an Additional Insured in the same manner County is under Section 3.1.4(C)(1)(a). A-E's Worker's Compensation policy shall contain a waiver of subrogation endorsement waiving all rights of subrogation against the District in the same manner as County under Section 3.1.4(C)(2). A-E's insurance policies shall waive all rights of subrogation against District in the same manner as against County under Section 3.1.4(C)(3).

2. The following shall be added to the Recitals:

WHEREAS, the District relies on County staff to carry out its duties pursuant to the Orange County Flood Control District Act, Water Code App. §§ 36-1 et seq., and County staff may request A-E to perform services under this Contract on behalf of District; and,

3. Article 1.4 shall be amended to include the following:

The term of this Contract is renewed for two (2) years effective November 17, 2023 through November 16, 2025 with a maximum allowable compensation of one million two hundred thousand (\$1,200,000) dollars; except as permitted in Paragraph 1.5 below.

4. Attachment B, Section II, Part B shall be amended to include the following:

Renewal Contract Amount Shall Not Exceed: \$1,200,000

- 5. Article 1.1.2 shall be amended to read as follows:
 - 1.1.2 A-E has offered, and County has accepted, the professional services of Darin Johnson, PE and A-E shall assign him/her to the Projects/Services.
- 6. Article 6.14.3 shall be amended to read as follows:
