II. ALTERATION OF TERMS

A. This Contract, together with Exhibits A, B, and C, attached hereto and incorporated herein, fully
expresses the complete understanding of COUNTY and CONTRACTOR with respect to the subject
matter of this Contract.

B. Unless otherwise expressly stated in this Contract no addition to, or alteration of the terms of this Contract or any Exhibits, whether written or verbal, made by the Parties, their officers, employees or agents shall be valid unless made in the form of a written amendment to this Contract, which has been formally approved and executed by both Parties.

III. ASSIGNMENT OF DEBTS

Unless this Contract is followed without interruption by another agreement between the parties hereto for the same services and substantially the same scope, at the termination of this Contract, CONTRACTOR shall assign to COUNTY any debts owing to CONTRACTOR by or on behalf of persons receiving services pursuant to this Contract. CONTRACTOR shall immediately notify by mail each of these persons, specifying the date of assignment, the County of Orange as assignee, and the address to which payments are to be sent. Payments received by CONTRACTOR from or on behalf of said persons, shall be immediately given to COUNTY.

IV. COMPLIANCE

A. COMPLIANCE PROGRAM - ADMINISTRATOR has established a Compliance Program for the purpose of ensuring adherence to all rules and regulations related to federal and state health care programs.

1. ADMINISTRATOR shall provide CONTRACTOR with a copy of the policies and
 procedures relating to ADMINISTRATOR's Compliance Program, Code of Conduct and access to
 General Compliance and Annual Provider Trainings.

2. CONTRACTOR has the option to provide ADMINISTRATOR with proof of its own
compliance program, code of conduct and any compliance related policies and procedures.
CONTRACTOR's compliance program, code of conduct and any related policies and procedures shall be
verified by ADMINISTRATOR's Compliance Department to ensure they include all required elements
by ADMINISTRATOR's Compliance Officer as described in this Compliance Paragraph to this Contract.
These elements include:

- b. Written standards, policies and/or procedures.
 - c. Compliance related training and/or education program and proof of completion.
- d. Communication methods for reporting concerns to the Compliance Officer.

- f. Methodology for detecting and correcting offenses.

g. Methodology/Procedure for enforcing disciplinary standards.

3. If CONTRACTOR does not provide proof of its own compliance program to
ADMINISTRATOR, CONTRACTOR shall internally comply with ADMINISTRATOR's Compliance
Program and Code of Conduct, CONTRACTOR shall submit to the ADMINISTRATOR within thirty
(30) calendar days of execution of this Contract a signed acknowledgement that CONTRACTOR will
internally comply with ADMINISTRATOR's Compliance Program and Code of Conduct.
CONTRACTOR shall have as many Covered Individuals it determines necessary complete
ADMINISTRATOR's annual compliance training to ensure proper compliance.

4. If CONTRACTOR elects to have its own compliance program, code of conduct and any 9 Compliance related policies and procedures reviewed by ADMINISTRATOR, then CONTRACTOR 10 shall submit a copy of its compliance program, code of conduct and all relevant policies and procedures 11 ADMINISTRATOR within thirty (30) calendar days of execution of this Contract. to 12 ADMINISTRATOR's Compliance Officer, or designee, shall review said documents within a reasonable 13 time, which shall not exceed forty-five (45) calendar days, and determine if CONTRACTOR's proposed 14 compliance program and code of conduct contain all required elements to ADMINISTRATOR's 15 satisfaction as consistent with the HCA's Compliance Program and Code of Conduct. 16 ADMINISTRATOR shall inform CONTRACTOR of any missing required elements and 17 CONTRACTOR shall revise its compliance program and code of conduct to meet ADMINISTRATOR's 18 required elements within thirty (30) calendar days after ADMINISTRATOR's Compliance Officer's 19 determination and resubmit the same for review by ADMINISTRATOR. 20

5. Upon written confirmation from ADMINISTRATOR's compliance officer that CONTRACTOR's compliance program, code of conduct and any compliance related policies and procedures contain all required elements, CONTRACTOR shall ensure that all Covered Individuals relative to this Contract are made aware of CONTRACTOR's compliance program, code of conduct, related policies and procedures and contact information for ADMINISTRATOR's Compliance Program.

B. SANCTION SCREENING – CONTRACTOR shall screen all Covered Individuals employed or retained to provide services related to this Contract semi-annually to ensure that they are not designated as Ineligible Persons, as pursuant to this Contract. Screening shall be conducted against the General Services Administration's Excluded Parties List System or System for Award Management, the Health and Human Services/Office of Inspector General List of Excluded Individuals/Entities, and the California Medi-Cal Suspended and Ineligible Provider List, the Social Security Administration's Death Master File at date of employment, and/or any other list or system as identified by ADMINISTRATOR.

For purposes of this Compliance Paragraph, Covered Individuals includes all employees,
 interns, volunteers, contractors, subcontractors, agents, and other persons who provide health care items
 or services or who perform billing or coding functions on behalf of ADMINISTRATOR.
 CONTRACTOR shall ensure that all Covered Individuals relative to this Contract are made aware of

If 24 CONTRACTOR becomes aware that a Covered Individual has become an Ineligible Person, 25 CONTRACTOR shall remove such individual from responsibility for, or involvement with, COUNTY 26 business operations related to this Contract. 27

7. CONTRACTOR shall notify ADMINISTRATOR immediately if a Covered Individual or 28 entity is currently excluded, suspended or debarred, or is identified as such after being sanction screened. 29 Such individual or entity shall be immediately removed from participating in any activity associated with 30 this Contract. ADMINISTRATOR will determine appropriate repayment from, or sanction(s) to 31 CONTRACTOR for services provided by ineligible person or individual. CONTRACTOR shall promptly 32 return any overpayments within forty-five (45) business days after the overpayment is verified by 33 ADMINISTRATOR. 34

C. GENERAL COMPLIANCE TRAINING - ADMINISTRATOR shall make General Compliance 35 Training available to Covered Individuals. 36

1. CONTRACTORS that have acknowledged to comply with ADMINISTRATOR's

F. Failure to comply with the obligations stated in this Compliance Paragraph shall constitute a 14 breach of the Contract on the part of CONTRACTOR and grounds for COUNTY to terminate the 15 Contract. Unless the circumstances require a sooner period of cure, CONTRACTOR shall have thirty 16 (30) calendar days from the date of the written notice of default to cure any defaults grounded on this 17 Compliance Paragraph prior to ADMINISTRATOR's right to terminate this Contract on the basis of such 18 default. 19

V. <u>CONFIDENTIALITY</u>

A. CONTRACTOR shall maintain the confidentiality of all records, including billings and any audio 22 and/or video recordings, in accordance with all applicable federal, state and county codes and regulations, as they now exist or may hereafter be amended or changed. 24

B. Prior to providing any services pursuant to this Contract, all members of the Board of Directors 25 or its designee or authorized agent, employees, consultants, subcontractors, volunteers and interns of 26 CONTRACTOR shall agree, in writing, with CONTRACTOR to maintain the confidentiality of any and 27 all information and records which may be obtained in the course of providing such services. This Contract 28 shall specify that it is effective irrespective of all subsequent resignations or terminations of 29 CONTRACTOR members of the Board of Directors or its designee or authorized agent, employees, 30 consultants, subcontractors, volunteers and interns. 31

VI. CONFLICT OF INTEREST

CONTRACTOR shall exercise reasonable care and diligence to prevent any actions or conditions that 34 could result in a conflict with COUNTY interests. In addition to CONTRACTOR, this obligation shall 35 apply to CONTRACTOR's employees, agents, and subcontractors associated with the provision of goods 36 and services provided under this Contract. CONTRACTOR's efforts shall include, but not be limited to 37

establishing rules and procedures preventing its employees, agents, and subcontractors from providing or 1 offering gifts, entertainment, payments, loans or other considerations which could be deemed to influence 2 or appear to influence COUNTY staff or elected officers in the performance of their duties.

VII. DELEGATION, ASSIGNMENT AND SUBCONTRACTS

A. CONTRACTOR may not delegate the obligations hereunder, either in whole or in part, without prior written consent of COUNTY. CONTRACTOR shall provide written notification of CONTRACTOR's intent to delegate the obligations hereunder, either in whole or part, to ADMINISTRATOR not less than sixty (60) calendar days prior to the effective date of the delegation. Any attempted assignment or delegation in derogation of this paragraph shall be void.

B. CONTRACTOR agrees that if there is a change or transfer in ownership of CONTRACTOR's business prior to completion of this Contract, and COUNTY agrees to an assignment of the Contract, the new owners shall be required under the terms of sale or other instruments of transfer to assume CONTRACTOR's duties and obligations contained in this Contract and complete them to the satisfaction 14 15 of COUNTY. CONTRACTOR may not assign the rights hereunder, either in whole or in part, without the prior written consent of COUNTY. 16

1. If CONTRACTOR is a nonprofit organization, any change from a nonprofit corporation to 17 any other corporate structure of CONTRACTOR, including a change in more than fifty percent (50%) of 18 the composition of the Board of Directors within a two (2) month period of time, shall be deemed an 19 assignment for purposes of this paragraph, unless CONTRACTOR is transitioning from a community 20 clinic/health center to a Federally Qualified Health Center and has been so designated by the Federal 21 Government. Any attempted assignment or delegation in derogation of this subparagraph shall be void. 22

2. If CONTRACTOR is a for-profit organization, any change in the business structure, 23 including but not limited to, the sale or transfer of more than ten percent (10%) of the assets or stocks of 24 CONTRACTOR, change to another corporate structure, including a change to a sole proprietorship, or a 25 change in fifty percent (50%) or more of Board of Directors or any governing body of CONTRACTOR 26 at one time shall be deemed an assignment pursuant to this paragraph. Any attempted assignment or 27 delegation in derogation of this subparagraph shall be void. 28

3. If CONTRACTOR is a governmental organization, any change to another structure, including a change in more than fifty percent (50%) of the composition of its governing body (i.e. Board 30 of Supervisors, City Council, School Board) within a two (2) month period of time, shall be deemed an 31 assignment for purposes of this paragraph. Any attempted assignment or delegation in derogation of this 32 subparagraph shall be void. 33

4. Whether CONTRACTOR is a nonprofit, for-profit, or a governmental organization, 34 CONTRACTOR shall provide written notification of CONTRACTOR's intent to assign the obligations 35 hereunder, either in whole or part, to ADMINISTRATOR not less than sixty (60) calendar days prior to 36 the effective date of the assignment. 37

5. Whether CONTRACTOR is a nonprofit, for-profit, or a governmental organization, 1 2 CONTRACTOR shall provide written notification within thirty (30) calendar days to ADMINISTRATOR when there is change of less than fifty percent (50%) of Board of Directors or any governing body of 3 CONTRACTOR at one time. 4

6. COUNTY reserves the right to immediately terminate the Contract in the event COUNTY 5 determines, in its sole discretion, that the assignee is not qualified or is otherwise unacceptable to 6 COUNTY for the provision of services under the Contract. 7

C. CONTRACTOR's obligations undertaken pursuant to this Contract may be carried out by means 8 of subcontracts, provided such subcontractors are approved in advance by ADMINISTRATOR, meet the 9 requirements of this Contract as they relate to the service or activity under subcontract, include any 10 provisions that ADMINISTRATOR may require, and are authorized in writing by ADMINISTRATOR 11 prior to the beginning of service delivery. 12

1. After approval of the subcontractor, ADMINISTRATOR may revoke the approval of the 13 subcontractor upon five (5) calendar days' written notice to CONTRACTOR if the subcontractor 14 subsequently fails to meet the requirements of this Contract or any provisions that ADMINISTRATOR 15 has required. ADMINISTRATOR may disallow subcontractor expenses reported by CONTRACTOR. 16

2. No subcontract shall terminate or alter the responsibilities of CONTRACTOR to COUNTY 17 pursuant to this Contract. 18

19 3. ADMINISTRATOR may disallow, from payments otherwise due CONTRACTOR, amounts claimed for subcontracts not approved in accordance with this paragraph. 20

4. This provision shall not be applicable to service agreements usually and customarily entered into by CONTRACTOR to obtain or arrange for supplies, technical support, and professional services 22 provided by consultants.

D. CONTRACTOR shall notify COUNTY in writing of any change in CONTRACTOR's status 24 with respect to name changes that do not require an assignment of the Contract. CONTRACTOR also 25 shall notify COUNTY in writing if CONTRACTOR becomes a party to any litigation against COUNTY, 26 or a party to litigation that may reasonably affect CONTRACTOR's performance under the Contract, as 27 well as any potential conflicts of interest between CONTRACTOR and COUNTY that may arise prior to 28 or during the period of Contract performance. While CONTRACTOR must provide this information 29 without prompting from COUNTY any time there is a change in CONTRACTOR's name, conflict of 30 interest or litigation status, CONTRACTOR must also provide an update to COUNTY of its status in 31 these areas whenever requested by COUNTY. 32

VIII. DISPUTE RESOLUTION

A. The Parties shall deal in good faith and attempt to resolve potential disputes informally. If the 35 dispute concerning a question of fact arising under the terms of this Contract is not disposed of in a 36 reasonable period of time by CONTRACTOR and ADMINISTRATOR, such matter shall be brought to 37

1 || the attention of the County Procurement Officer by way of the following process:

CONTRACTOR shall submit to the County Deputy Purchasing Agent a written demand for
 a final decision regarding the disposition of any dispute between the Parties arising under, related to, or
 involving this Contract, unless COUNTY, on its own initiative, has already rendered such a final decision.

2. CONTRACTOR's written demand shall be fully supported by factual information, and, if
such demand involves a cost adjustment to the Contract, CONTRACTOR shall include with the demand
a written statement signed by an authorized representative indicating that the demand is made in good
faith, that the supporting data are accurate and complete, and that the amount requested accurately reflects
the Contract adjustment for which CONTRACTOR believes COUNTY is liable.

B. Pending the final resolution of any dispute arising under, related to, or involving this Contract,
CONTRACTOR must proceed diligently with the performance of services secured via this Contract,
including the delivery of goods and/or provision of services. CONTRACTOR's failure to proceed
diligently shall be considered a material breach of this Contract.

C. Any final decision of COUNTY shall be expressly identified as such, shall be in writing, and shall
be signed by a COUNTY Deputy Purchasing Agent or designee. If COUNTY does not render a decision
within ninety (90) calendar days after receipt of CONTRACTOR's demand, it shall be deemed a final
decision adverse to CONTRACTOR's contentions.

D. This Contract has been negotiated and executed in the State of California and shall be governed by and construed under the laws of the State of California. In the event of any legal action to enforce or interpret this Contract, the sole and exclusive venue shall be a court of competent jurisdiction located in Orange County, California, and the Parties hereto agree to and do hereby submit to the jurisdiction of such court, notwithstanding Code of Civil Procedure Section 394. Furthermore, the Parties specifically agree to waive any and all rights to request that an action be transferred for adjudication to another county.

IX. EMPLOYEE ELIGIBILITY VERIFICATION

CONTRACTOR attests that it shall fully comply with all federal and state statutes and regulations 26 regarding the employment of aliens and others and to ensure that employees, subcontractors and 27 consultants performing work under this Contract meet the citizenship or alien status requirement set forth 28 in federal statutes and regulations. A. Unless otherwise specified in writing by ADMINISTRATOR, Equipment is defined as all

X. EQUIPMENT

property of a Relatively Permanent nature with significant value, purchased in whole or in part by 1 ADMINISTRATOR to assist in performing the services described in this Contract. 2 "Relatively Permanent" is defined as having a useful life of one (1) year or longer. Equipment which costs \$5,000 or 3 over, including freight charges, sales taxes, and other taxes, and installation costs are defined as Capital 4 Assets. Equipment which costs between \$600 and \$5,000, including freight charges, sales taxes and other 5 taxes, and installation costs, or electronic equipment that costs less than \$600 but may contain PHI or PII, 6 are defined as Controlled Equipment. Controlled Equipment includes, but is not limited to phones, tablets, 7 audio/visual equipment, computer equipment, and lab equipment. The cost of Equipment purchased, in 8 whole or in part, with funds paid pursuant to this Contract shall be depreciated according to GAAP. 9

B. CONTRACTOR shall obtain ADMINISTRATOR's written approval prior to purchase of any
Equipment with funds paid pursuant to this Contract. Upon delivery of Equipment, CONTRACTOR shall
forward to ADMINISTRATOR, copies of the purchase order, receipt, and other supporting
documentation, which includes delivery date, unit price, tax, shipping and serial numbers.
CONTRACTOR shall request an applicable asset tag for said Equipment and shall include each purchased
asset in an Equipment inventory.

C. Upon ADMINISTRATOR's prior written approval, CONTRACTOR may expense to COUNTY
the cost of the approved Equipment purchased by CONTRACTOR. To "expense," in relation to
Equipment, means to charge the proportionate cost of Equipment in the fiscal year in which it is purchased.
Title of expensed Equipment shall be vested with COUNTY.

D. CONTRACTOR shall maintain an inventory of all Equipment purchased in whole or in part with funds paid through this Contract, including date of purchase, purchase price, serial number, model and type of Equipment. Such inventory shall be available for review by ADMINISTRATOR, and shall include the original purchase date and price, useful life, and balance of depreciated Equipment cost, if any.

E. CONTRACTOR shall cooperate with ADMINISTRATOR in conducting periodic physical inventories of all Equipment. Upon demand by ADMINISTRATOR, CONTRACTOR shall return any or all Equipment to COUNTY.

F. CONTRACTOR must report any loss or theft of Equipment in accordance with the procedure approved by ADMINISTRATOR and the Notices Paragraph of this Contract. In addition, CONTRACTOR must complete and submit to ADMINISTRATOR a notification form when items of Equipment are moved from one location to another or returned to COUNTY as surplus.

G. Unless this Contract is followed without interruption by another agreement between the Parties
for substantially the same type and scope of services, at the termination of this Contract for any cause,
CONTRACTOR shall return to COUNTY all Equipment purchased with funds paid through this Contract.
H. CONTRACTOR shall maintain and administer a sound business program for ensuring the proper
use, maintenance, repair, protection, insurance, and preservation of COUNTY Equipment.

XI. EXPENDITURE AND REVENUE REPORT

A. No later than sixty (60) calendar days following termination of each period or fiscal year of this
Contract, CONTRACTOR shall submit to ADMINISTRATOR, for informational purposes only, an
Expenditure Report for the preceding fiscal year, or portion thereof. Such report shall be prepared in
accordance with the procedure that is provided by ADMINISTRATOR and GAAP.

B. CONTRACTOR may be required to submit periodic Expenditure Reports throughout the term of the Contract.

XII. FACILITIES, PAYMENTS, AND SERVICES

A. CONTRACTOR agrees to provide the services, staffing, facilities, and supplies in accordance with this Contract. COUNTY shall compensate, and authorize, when applicable, said services. CONTRACTOR shall operate continuously throughout the term of this Contract with at least the minimum number and type of staff which meet applicable federal and state requirements, and which are necessary for the provision of the services hereunder.

XIII. INDEMNIFICATION AND INSURANCE

A. CONTRACTOR agrees to indemnify, defend with counsel approved in writing by COUNTY, 17 and hold COUNTY, its elected and appointed officials, officers, employees, agents and those special 18 districts and agencies for which COUNTY's Board of Supervisors acts as the governing Board 19 ("COUNTY INDEMNITEES") harmless from any claims, demands or liability of any kind or nature, 20including but not limited to personal injury or property damage, arising from or related to the services, 21 products or other performance provided by CONTRACTOR pursuant to this Agreement. If judgment is 22 entered against CONTRACTOR and COUNTY by a court of competent jurisdiction because of the 23 concurrent active negligence of COUNTY or COUNTY INDEMNITEES, CONTRACTOR and 24 COUNTY agree that liability will be apportioned as determined by the court. Neither Party shall request 25 a jury apportionment. 26

If there are any questions regarding the cause of death of any person served pursuant to this 14 Contract who was diagnosed with a terminal illness, or if there are any unusual circumstances related to 15 the death, CONTRACTOR shall immediately notify ADMINISTRATOR in accordance with this 16 Notification of Death Paragraph.

XXII. <u>NOTIFICATION OF PUBLIC EVENTS AND MEETINGS</u>

A. CONTRACTOR shall notify ADMINISTRATOR of any public event or meeting funded in whole or in part by COUNTY, except for those events or meetings that are intended solely to serve clients or occur in the normal course of business.

B. CONTRACTOR shall notify ADMINISTRATOR at least thirty (30) business days in advance of any applicable public event or meeting. The notification must include the date, time, duration, location and purpose of the public event or meeting. Any promotional materials or event related flyers must be approved by ADMINISTRATOR prior to distribution. 26

XXIII. RECORDS MANAGEMENT AND MAINTENANCE

A. CONTRACTOR, its officers, agents, employees and subcontractors shall, throughout the term of this Contract, prepare, maintain and manage records appropriate to the services provided and in accordance with this Contract and all applicable requirements.

1. CONTRACTOR shall maintain records that are adequate to substantiate the services for which claims are submitted for reimbursement under this Contract and the charges thereto. Such records shall include, but not be limited to, individual patient charts and utilization review records.

B. CONTRACTOR shall implement and maintain administrative, technical and physical safeguards
to ensure the privacy of PHI and prevent the intentional or unintentional use or disclosure of PHI in
violation of the HIPAA, federal and state regulations. CONTRACTOR shall mitigate to the extent
practicable, the known harmful effect of any use or disclosure of PHI made in violation of federal or state
regulations and/or COUNTY policies.

XXV. <u>REVENUE</u>

A. THIRD-PARTY REVENUE – CONTRACTOR shall make every reasonable effort to obtain all available third-party reimbursement for which persons served pursuant to this Contract may be eligible. Charges to insurance carriers shall be on the basis of CONTRACTOR's usual and customary charges.

B. PROCEDURES – CONTRACTOR shall maintain internal financial controls which adequately ensure proper billing and collection procedures. CONTRACTOR's procedures shall specifically provide for the identification of delinquent accounts and methods for pursuing such accounts. CONTRACTOR shall provide ADMINISTRATOR, monthly, a written report specifying the current status of fees which are billed, collected, transferred to a collection agency, or deemed by CONTRACTOR to be uncollectible.

XXVI. <u>SEVERABILITY</u>

12	A. The parties agree to the following terms and definitions, and to those terms and definitions that,

d. Duration: The length of time for which the services will be provided. This may involve
a set number of hours, days, weeks or months; it may also be on an ongoing basis until a specific goal is
achieved.

5. Small Targeted Group Event means a focused gathering with a limited number of
participants, often ranging from a few individuals to several dozen. It caters to a specific audience sharing
common interests or characteristics, emphasizing interaction and engagement through discussions,
workshops, and networking. Examples may include but are not limited to: Prenatal Nutrition Workshop
for Expectant Mothers, Diabetes Support Group Meeting, or teen Health Talk.

6. Large Community Group Event means a sizeable event that draws a broader audience,
 ranging from dozens to potentially thousands of participants. It aims to engage a diverse cross-section of
 the community, with an emphasis on raising awareness, fostering community involvement, and promoting
 public engagement. Examples may include but are not limited to: OC Fair, Cultural/Civic Celebrations,
 Festivals, Carnivals, Parades, and Community Concert or Movie Nights.

7. One-on-One / Door-to-Door Interactions means CONTRACTOR or subcontractor staff
visiting individuals' homes to provide information related to OC Public Health Services" (PHS) programs
and public health initiatives. One-on-One / Door-to-Door Interactions are a key part of community
outreach and engagement, and help to ensure that individuals are aware of and have access to the public
health services that they need. Activities during these interactions may include but are not limited to:

a. Distributing Materials: CONTRACTOR or subcontractor may distribute educational materials, program brochures, and PHS business cards to individuals.

b. Assessing Needs: CONTRACTOR or subcontractor may assess the needs of individuals
that they visit to determine what services and/or resources the individuals may benefit from.

c. Linkage to Services: Based on needs assessment, CONTRACTOR or subcontractor may
 provide information as well as facilitate connections to relevant services and resources.

8. Assessment means the process by which CONTRACTOR or subcontractor identifies and

prioritizes health and social needs of the community, family, or individual, and identify resources such as
organizations, facilities, and programs in the community that are potentially available to address those
needs.

9. Referrals means the process by which individuals or groups are directed to specific healthcare
or social service programs in order to address their health and well-being needs. The goal is to connect
people with the appropriate resources and support available within the public health and community
services sector. This ensures that they receive the necessary care, education, or assistance to improve both
health and quality of life. The referral process often involves assessing an individual's or community's
needs, identifying suitable services, and facilitating entry into public health and community programs or
services to promote overall well-being and health.

10. Linkage of Care means the comprehensive process of connecting individuals with the
necessary services and resources to address their specific needs, which may be medical, social,
psychological, or otherwise. This process usually follows the identification of a need, and ensures that
individuals access and receive the appropriate care and support to manage their situation effectively.

Linkage of care aims to bridge the gap between identifying an individual's need(s) and ensuring that the individual receives the required services. These services may include but are not limited to medical treatment, public health home visits, counseling, preventive measures, social services such as food assistance and housing support, mental health services, educational support services, substance abuse treatment programs, or legal aid services. The goals is to provide a holistic approach to care that addresses all aspects of an individual's well-being, ensuring that they receive comprehensive support that extends beyond healthcare to include all facets of their lives.

II. <u>BUDGET</u>

A. COUNTY shall pay CONTRACTOR in accordance with the Payments Paragraph for each
Period as set forth in this Exhibit A to the Contract.

2. Responsibilities of CONTRACTOR

To implement appropriate and reasonable administrative, technical, and 26 physical safeguards to protect the security, confidentiality and integrity of DHCS PI and PII, to protect 27 against anticipated threats or hazards to the security or integrity of DHCS PI and PII, and to prevent use 28 or disclosure of DHCS PI or PII other than as provided for by this Personal Information Privacy and 29 Security Contract. CONTRACTOR shall develop and maintain a written information privacy and security 30 program that include administrative, technical and physical safeguards appropriate to the size and 31 complexity of CONTRACTOR's operations and the nature and scope of its activities, which incorporate 32 the requirements of Paragraph (c), below. CONTRACTOR will provide COUNTY with its current policies 33 upon request. 34

3) If the data obtained by CONTRACTOR from COUNTY includes PII, 8 CONTRACTOR shall also comply with the substantive privacy and security requirements in the Computer 9 Matching and Privacy Protection Act Contract between the SSA and the California Health and Human 10 Services Agency (CHHS) and in the Contract between the SSA and DHCS, known as the Information 11 Exchange Contract (IEA). The specific sections of the IEA with substantive privacy and security 12 requirements to be complied with are sections E, F, and G, and in Attachment 4 to the IEA, Electronic 13 Information Exchange Security Requirements, Guidelines and Procedures for Federal, State and Local 14 Agencies Exchanging Electronic Information with the SSA. f. Availability of Information. To make DHCS PI and PII available to the DHCS and/or
COUNTY for purposes of oversight, inspection, amendment, and response to requests for records,
injunctions, judgments, and orders for production of DHCS PI and PII. If CONTRACTOR receives DHCS
PII, upon request by COUNTY and/or DHCS, CONTRACTOR shall provide COUNTY and/or DHCS
with a list of all employees, contractors and agents who have access to DHCS PII, including employees,
contractors and agents of its subcontractors and agents.

g. Cooperation with COUNTY. With respect to DHCS PI, to cooperate with and assist the
COUNTY to the extent necessary to ensure the DHCS's compliance with the applicable terms of the CIPA
including, but not limited to, accounting of disclosures of DHCS PI, correction of errors in DHCS PI,
production of DHCS PI, disclosure of a security breach involving DHCS PI and notice of such breach to
the affected individual(s).
